In quoting the following paragraph from a Singapore paper, the Times of Malaya describes it as "a joke in sober earnest":—

Mr. Gerald Mugliston, while in Penang, was regularly seen in the saddle for the Roadster's Race at the Turf Club meetings under the nom de plume of "Mr. Harringay."

Wednesday's Times of Malaya states: A case of interest to planters was heard in the Tapah Court yesterday and decided in favour of the defendant Estate. A firm of Estate Agents was sued by the District Surgeon for \$3.04 and costs, being Hospital fees due on a coolie named Govinden. The man, who said he came from Elba Estate, was eighteen days in hospital and there died. On the bill being presented at the estate, a reply was made that no coolies had been sent to Hospital during the month stated and that the only Govinden on the estate had worked throughout, as was proved by the check roll; moreover, the estate Govinden is still alive, whereas the other Govinden died under treatment. The custom is to send a letter with sick coolies asking for admission to Hospital. There was none in this case, but the District Surgeon maintained that the coolie said he came from Elba and therefore the estate must pay for him. The Magistrate decided against the Medical authorities and the latter are now wondering how they will get a refund from the Revenue.
