## SUNGEI RAMAL SYND LTD.

After liabilities have been provided for an amount of \$44,043.12 stands to the credit of the profit and loss account of the Sungei Ramal Estate, according to the Chairman's speech at the recent general meeting of the company held in Kuala Lumpur.

The chairman stated that all the Company's records were lost during the occupation but the auditors were satisfied that the accounts presented to the meeting constituted a reasonable basis on which to reconstruct the books.

"Full accounts for 1946 will be presented at a meeting to be called later this year," he stated.

The chairman said that there was little to add to the earlier report on the condition of the estate which had been issued to the shareholders.

A sum of \$3,000 was voted as directors' fees and a compassionate allowance of \$9,000 was voted to Mr. C. Phillips on his retirement after many years service as manager with the company.
