3. We will also inform that once our documents are ready, SCT 3rd Term Committee will announce and distribute our final report (Financial and Non-Financial). We also take this opportunity to openly invite SCT 1st and 2nd Term to come forward and provide accurate reports to the residents.

4. Since our mission is already completed, once item (3) is completed, SCT will be dissolved.

Press Release:
Out-Of-Court Settlement After Six Long Years Of Struggle

24 September 2010 marks a Day of Victory for all Nature Lovers, Environmentalists and the Residents of Puchong because following the initial announcement by the Selangor Government in early January 2010, we finally achieve an Out-of-Court Settlement with the Selangor Government where the Cemetery Project in Ayer Hitam Forest Reserve is officially cancelled and the land for the Cemetery Project is reverted back to Forest Reserve.

Because the Out-of-Court Settlement Offered by the Selangor Government is in-line with the Main Objective of our Judicial Review Against the Selangor Government, after seeking professional advice, SCT decided to accept this Out-of-Court Settlement.

SCT makes this latest announcement so that all fellow residents can now enjoy Peace of Mind after years of unnecessary stress and worries and start focusing on your future plans.

Fellow Residents and Friends, we hope that all of us will continue to work hard in hand to protect this precious piece of Forest Reserve because the only reason IT IS STILL HERE TODAY is that all residents have fought so hard, so long and so painfully to KEEP IT THERE UNTOUCHED. (Time flies, we have gone through two state governments and SCT is already in her 3rd Term)


We, SCT 3rd Term Committee (25 June 2009 – 25 June 2011), strongly believes that a community organization (in fact any social organization) like SCT should hold strongly to the Principle of Public Accountability and Transparency. Therefore, we have kept proper records of work (Agenda, Minutes of Meeting, Important Events and Financial Accounts). Currently, the only document we do not have is the official 'Out-of-Court Settlement Decision' Document from the court. Once, we get the document, we will compile and distribute the report.

Although SCT 3rd Term Committee strongly feels that we have the responsibilities to also publish Work and Financial Reports from SCT 1st and 2nd Term Committee for the purpose of completeness, after going through their files, we found the documents to be very disorganized. Thus, to avoid inaccurate reporting, we take this opportunity to openly invite the Leadership of SCT 1st and 2nd Term Committee to come forward and help provide accurate reports to the residents. This will definitely be a big win to the Principle of Public Accountability.

SCT 3rd Term Committee would again like to assure fellow residents that we would go ahead to publish and distribute SCT 3rd Term Committee Reports once we obtain the official 'Out-of-Court Settlement Decision' Document from the court regardless whether the 1st Term and 2nd Term SCT reports are ready or not.



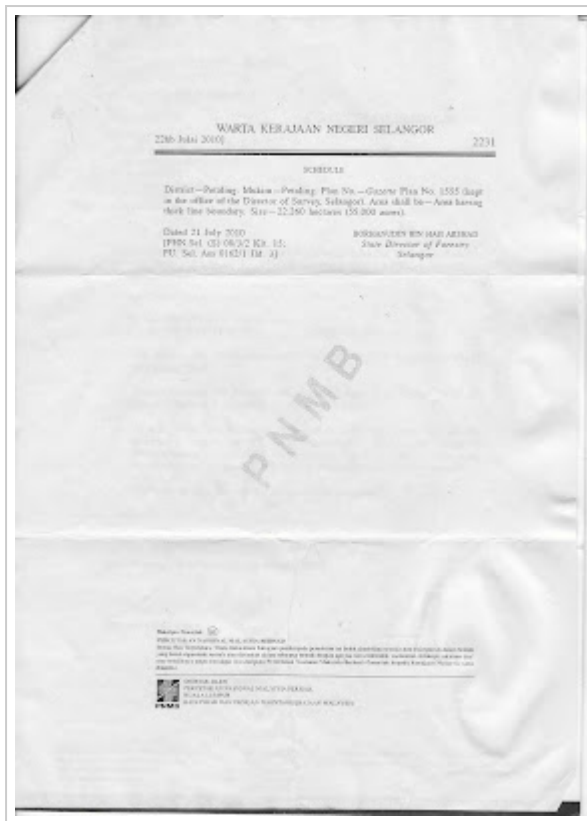

In exercise of the powers conferred by subsection 7(1) of the National Forestry Act 1984 [Act 311] as adopted by the National Forestry Act (Adoption) Enactment 1984 (No. 2460), the State Authority of Selangor, with the approval of the State Executive Council, hereby declares the permanent reserved forest as described in the Schedule, as a permanent forest with effect from the date of publication of this notification in the Gazette.



2. Letters that we have provided to T. J. Chin & Co requesting for the breakdown of legal expenses:

First of all, SCT wrote to T. J. Chin & Co on 6 September 2009 and then 12 October 2009 to request for the breakdown of legal expenses. In both letters, we do not receive any reply from T. J. Chin & Co.

Because of that, 1 June 2010, four SCT committee members (Mr. Koh Kok Siong, Mr. Lau Seng You, Mr. Lee Wai Hong and Mr. Ng Chee Kwong) appointed Norma Goh & Co to write to T. J. Chin & Co for the same matter and we still do not get the breakdown of legal expenses.

Then, on 7 July 2010, SCT 3rd Term Committee successfully changed the applicant name of our Judicial Review from SCT 1st Term Chairman to Mr. Lee Wai Hong (SCT 3rd Term Chairman - current) and thus obtain the Locus Standi (Legal Position) to pursue this case.

Because of that, SCT 3rd Term Committee appointed Norma Goh and Co to officially pursue this matter with T. J. Chin & Co using Mr. Lee Wai Hong Locus Standi on 20 August 2010. (The expenses for Appointment of Norma Goh & Co to pursue this matter amounting to RM 5,000.00 is fully borne personally by SCT 3rd Term Committee without using any public donated contribution).

Norma Goh & Co then reported this to the Senior Assistant Registrar (Shah Alam Court) and on 24 September 2010, Norma Goh & Co informed us that T. J. Chin & Co will reply us within 2 weeks.


